ABSTRACT

This inventory represents the status and use of all permitted, certificated, claims of vested right groundwater rights, and exempt domestic wells located within Eagle Valley, Hydrographic Basin 8-104, for water year 2016 (October 1, 2015 through September 30, 2016). Also included are summary graphs and additional data associated with basin transfers, aquifer storage, use of effluent, streamflow measurements, and depth to groundwater.

The data presented are valid for the period of this report and may vary from previously published figures as water rights within the basin are subject to administrative action, such as certification, cancellation, forfeiture or withdrawal on a continual basis.

For water year 2016, the committed water resource totaled 9,735 acre-feet, with estimated pumpage of **4,248 acre-feet**. This includes an estimated 889 acre-feet pumped from exempt domestic wells.

Municipal was the largest manner of use within Eagle Valley. For water year 2016, appropriations for municipal totaled 6,810 acre-feet, with pumpage of 3,190 acre-feet. The second largest manner of use was pumping by exempt domestic wells.

² Committed groundwater resource data are accurate for December 2017. Manner of use category totals vary over time, as rights are not necessarily static. Rights may be subject to change applications, certification, withdrawals, forfeiture and cancellations; each of these circumstances could affect the duty, diversion rate and acreage associated with a given right. The value associated with each manner of use category does not include those portions that have been relinquished in support of domestic wells. A query of the NDWR Well Log Database indicates that 889 domestic wells existed in the basin during water year 2016. The committed domestic water resource is considered to be 2 acre-feet per domestic well, or 1,778 acre-feet annually.

PURPOSE AND SCOPE

The primary purpose of this report is to inventory all of the groundwater resources allocated and described by the Office of the State Engineer, Nevada Division of Water Resources (NDWR), and to estimate the amount of groundwater pumped within Eagle Valley, Hydrographic Basin 8-104, for the water year beginning October 1, 2015 and ending September 30, 2016 (water year 2016). This report estimates the amount of groundwater pumped under the permits and certificates issued by the State Engineer, claims of vested right, and the amount pumped by exempt domestic wells within the basin.

DESCRIPTION OF THE STUDY AREA




Figure 1. Eagle Valley (Hydrographic Basin 8-104) physiographic map.

Eagle Valley is located in west central Nevada. This basin occupies approximately 71 square miles, the majority of which is in Carson City County; small portions of the basin extend into Douglas and Washoe Counties. Adjacent hydrographic basins are Lake Tahoe Basin (6-090) to the west, Washoe Valley (6-089) to the north, Dayton Valley (8-103) to the east; and Carson Valley (8-105) to the south (Figure 1). The exterior boundary of Eagle Valley is as described by Designation Order 424, issued by the Nevada State Engineer on February 23, 1972, and by Designation Order 874, issued on July 29, 1985.

Eagle Valley is bounded on the west by the Carson Range of the Sierra Nevada, which is the primary watershed for the basin. The Virginia Range forms the north boundary, and Prison Hill borders the basin to the southeast; a low ridge extending from the Virginia Range south to Prison Hill forms the eastern boundary. The southern boundary is formed by a low alluvial rise and intermittent hills separating Eagle Valley from Carson Valley.

The U.S. Geological Survey (USGS) operates six stream gaging stations in Eagle Valley (see Figure 1). Stations #10310485, #10310500, and #10310518 measure streamflow along Clear Creek. Stations #10311100, #10311200, and #10310600 measure streamflow along Kings Canyon, Ash Canyon, and Voltaire Canyon Creeks, respectively. GROUNDWATER LEVELS

Depths to groundwater in Eagle Valley are measured on a periodic basis by multiple agencies at the following sites (Figure 2):

The water level data and a hydrograph for each site are available from the Water Level Data page of the NDWR website (<http://water.nv.gov/data/waterlevel/>). Data retrievals are organized by hydrographic basin. In addition to the sites above, the USGS monitors a network of wells whose data are available directly from their website (<http://nevada.usgs.gov>).

METHODS TO ESTIMATE PUMPAGE




Figure 3. Eagle Valley historical pumpage by manner of use.




Figure 4. Percentage of 2016 groundwater pumpage by manner of use.




Figure 5. Comparison between 2016 groundwater commitments and estimated pumpage.

This report estimates the amount of groundwater pumped under claims of vested rights and the permits and certificates issued by the State Engineer, as well as the amount pumped by exempt domestic wells in the valley. Table 1 and Figure 3 show historical pumpage by manner of use; Figure 4 shows percentage of groundwater pumped by manner of use; and Figure 5 compares groundwater appropriations and pumpage by manner of use. The following methods were used to arrive at the estimated pumpage:

- Where totalizing meters were in place, meter readings were taken and compared with previous data (if available).
- Where there were no flow meters or other reliable options for estimating pumpage and the use was irrigation, pumpage was estimated by dividing the Net Irrigation Water Requirement (NIWR) for the crop grown by the efficiency of the irrigation method used, then multiplying by the number of acres irrigated. Irrigation efficiencies associated with three types of irrigation methods are: pivot at 85%; wheel lines or other hand moved sprinklers at 75%; and flood at 60%. The pumpage amount estimated by this method was limited by the duty of the permit. For places where groundwater rights were supplemental to surface water, groundwater use was estimated using the NIWR method above, but adjusted based on available surface water for the year. Evapotranspiration and NIWR data by basin can be found on the NDWR website at: <http://water.nv.gov/Evapotranspiration.aspx>.
- Where meters were not present, previous data were not available, and the manner of use was not irrigation, pumpage was estimated by applying the annual duty associated with the certificate (if the water right was perfected), permit or claim, if the use was as described in the certificate, permit or claim. If the use was not as described in the certificate, permit or claim, a value was estimated based upon the circumstances of use for the subject year.
- Carson City Department of Public Works Water Division (CCPW) is the primary water purveyor in Eagle Valley and provides NDWR with monthly pumping totals on a quarterly basis as a condition of permits under which their water is appropriated. Douglas County and Sierra Estates General Improvement District also report pumpage within Eagle Valley on a quarterly basis. These reported totals are used directly as the amounts pumped for those entities.
- Exempt domestic wells may be drilled and utilized where water service from a purveyor is not available. These types of wells do not require a permit from the State Engineer if

they do not pump more than two acre-feet per year as provided by Nevada Revised Statutes (NRS) [534.180](#). [NRS 534.013](#) defines this category of domestic use as follows: *“Domestic use or domestic purposes extends to culinary and household purposes directly related to a single family dwelling, including, without limitation, the watering of a family garden and lawn and the watering of livestock and any other domestic animals or household pets.”* The number of exempt domestic wells in the basin was determined by a query of the NDWR Well Log Database. The amount of water pumped annually by exempt domestic wells is estimated to be one acre-foot per well in Eagle Valley, or 889 acre-feet.

MUNICIPAL SUPPLY IN ADDITION TO EAGLE VALLEY GROUNDWATER

CCPW has several sources of water in addition to groundwater pumped within Eagle Valley. All additional sources to the municipal system are reported to the Nevada State Engineer and are summarized in Table 2 and Table 3. Surface water sources include direct diversions from Kings and Ash Creeks, induction wells on the Carson River, and importation from the Marlette Water System. Groundwater sources include wells in Carson Valley and Dayton Valley within the Carson City municipal service area, and the North Douglas County and Carson City Water Line intertie. Water imported to the municipal system that exceeds demand is stored in the aquifer or exported to Dayton Valley through transmission pipeline shown in Table 3. Effluent generated within Eagle Valley is treated and reused.

The Marlette/Hobart system was originally constructed in the 19th century to meet the water needs of Virginia City, and continues to supply water to Virginia City and Carson City. Water is diverted from Marlette Lake (within the Lake Tahoe Basin) and delivered to Hobart Reservoir, located in Washoe Valley. From Hobart Reservoir, water is delivered by pipeline to Carson City, treated, and commingled with water from Ash Canyon and North Kings Canyon Creeks into CCPW's municipal supply system shown in Table 2.

CCPW operates aquifer storage and recovery (ASR) programs in Eagle Valley under Nevada State Engineer's ASR Permit R-004 and R-022. The terms of Permit R-004 allow for recharge of up to 700 acre-feet per year of water from the Marlette/Hobart system. After municipal demand is met, excess water is released into the Vicee Canyon drainage, where it flows approximately two miles downstream to rapid infiltration basins. Permit R-022 allows for recharge of up to 250 acre-feet per year of treated water from Ash Canyon Creek and Kings Canyon Creek. Three existing CCPW wells in Eagle Valley are the recharge injection wells. Injection will occur during periods of low water demand when there is sufficient excess water available. The amount of water diverted to aquifer storage under R-004 and R-022 is shown in Table 2. No recovery of stored water occurred in 2016.

CCPW operates a wastewater treatment plant in eastern Eagle Valley that treats domestic and industrial wastewater received from sewer connections within the Carson City service area. Use of effluent for irrigation is authorized by the Nevada State Engineer under secondary Permits 25727 and 30450, and by the Nevada Division of Environmental Protection under Permit

NEV90008. Treated effluent is used for irrigation of golf courses, sports fields, the landscaping of several street medians, and at the treatment plant within Eagle Valley. When demand is low, effluent is pumped to a storage reservoir in Brunswick Canyon, approximately three miles east of the plant. Effluent deliveries for reuse in 2016 are shown in Table 3.³

OWNER OF RECORD	The owner(s) of the water right as recorded in the files of the State Engineer.
