

## New Boundary Line Adjustment & Reversion-Lot Consolidation Applications can now be uploaded by the applicant.

If you have an ACA account with <u>Douglas County</u> currently, you just need to log in:

- Link to ACA:
- If you don't have an account you will need to create one. If you have an account with Washoe/Reno we will need to do a 1 time "connection" on the back end. We would need to know the user name and/or email you use to log in. Please send to planning@douglasnv.us.
- Click on Planning
- Click on Create an Application by address. (If your property doesn't have an address, put "0" for a street number and then enter the "street name" and it will populate the parcel numbers that you can select from. If this does not work you will need to email the application to <a href="mailto:planning@douglasnv.us">planning@douglasnv.us</a>)
- If you upload and create your submittal this way an actual application is not needed.
  - We have created a signature page only that you would upload in place of the application.
  - We have also created a <u>list of required documents</u> specific only to these two types of applications.
  - Each document required by the submittal checklist must be included in pdf format. The pdf files must be flattened and unprotected allowing read/write access by staff.
  - Naming conventions please name the pdf documents as shown below prior to uploading:
