#### **PUBLIC COMMENT (No Action)**

Public comments submitted prior to the Douglas County Local Emergency Planning Committee meeting have been complied and made a part of the supporting materials that have been provided to the Douglas County Local Emergency Planning Committee members and public for review.

Amy Ray read into record an update sent in by Jeanne Freeman at Carson City Health and Human Services:

Carson City Health and Human Services continues to offer community-based COVID testing and vaccinations. The cases in Douglas County have been declining, which is a positive note. As such, the frequency of CCHHS doing Community-Based testing will likely drop off in the next 4-6 weeks. CCHHS is offering all three types of vaccines at the community vaccination events. Third doses of Moderna and Pfizer are available for those who are moderately to severely immunocompromised as identified through self-attestation. Booster doses of Pfizer are also available at the community vaccination events for those who completed their two-dose series at least six months ago. If there are employers who have 25 or more employees who would like to receive the COVID vaccine and would like us to come in and administer the vaccine, please reach out to Jeanne Freeman at jmfreeman@carson.org.

Carson City Health and Human Services is also conducting 65 flu vaccination events this month. This week CCHHS has been in the Douglas County Schools vaccinating students and staff. We will be at Douglas High School on Saturday, October 16th from 9am-1pm administering flu vaccinations and COVID vaccinations. Please share the information for the Saturday event with your staff and family members.

Holly Megee stated she would send out a flyer regarding the COVID and Flu Vaccine Clinic taking place at Douglas High School on October  $16^{th}$ .

Ryan Gerchman from Department of Emergency Management noted the below:

- 1. We want to share that the NIMS/Preparedness Framework went out to EMS in email and printed copies will be available soon.
- 2. THIRA/SPR draft should be coming soon to review and make edits.
- 3. Integrated Preparedness Plan (IPP) will have a workshop at the end of the year to assist locals to select a Priority to focus on for EMPG and other programs.
- 4. New Tribal FIT starting 10/11, Crystal Harjo. DEM is currently recruiting for a Tribal Health position.

- 4. For Presentation Only. Discussion by National Weather Service Reno on the autumn/winter weather outlook and any other concerns including post-fire flooding. (Chris Smallcomb) 5 Minutes.
  - October is looking promising for near to above normal precipitation and cooler than normal temps -Monday morning rain/snow showers and then looks somewhat active around the 18th-22nd roughly based on our models.
  - November is leaning drier than normal, at least the first week or two, but not a slam-dunk.
  - Weak La Nina condition in Pacific will drive the rest of winter historically for us that means a wide range of possibilities could see another dry winter or we could see a rather wet one (e.g. 2016-17 was a weak La Nina)
  - Will need to be mindful of post-fire flooding on the Tamarack Burn, especially communities along Hwy 395 where the fire burned the steep slopes immediately above them. Short periods of higher intensity rainfall is all it takes to trigger debris flows and flooding. May come with little to even no warning. Just the nature of limited predictability of these hazards.
